

Innovate2Build Win an iPad Game by GRAITEC

Rules

ARTICLE 1: ORGANIZING COMPANY

The company GRAITEC INNOVATION, a Société par actions simplifiée with a capital of 6093750,00 euros, with its registered office at 20 rue de Provence, 75009 Paris, France, registered with the Trade and Companies Register of RCS : Evry B 509 080 008 under number 50908000800022, organizes from February 12 to 29, 2024, inclusive, a free and no-purchase-necessary game on the dedicated page of GRAITEC Innovate2Build <https://webinars.graitec.com/innovate2build>, hereinafter referred to as the Game.

The terms of participation in the Game and the procedures for selecting winners are described in these rules (hereinafter referred to as "the Regulation").

ARTICLE 2 – OPERATION DATES

The Game takes place from February 12 to 29, 2024 inclusive.

ARTICLE 3 – PARTICIPANTS

The game is open to any professional in construction industry from France, UK, Germany, Spain, Portugal, Italy, Poland, Romania, Czech Republic, Slovakia, Canada, United States of America, excluding employees of the GRAITEC Group and members of their family aged 18 or older, as well as GRAITEC partners.

Any participation in this Game must necessarily comply with the terms of use of this regulation.

Any participation not in accordance with the characteristics stated above will not be considered. Participants authorize all verifications regarding their identity, age, postal address, or the loyalty and sincerity of their participation. Any false declaration or indication of false identity or address leads to the immediate elimination of the participant.

ARTICLE 4 – PARTICIPATION PROCEDURES

Participation in this game is free and without obligation to purchase during the duration of the contest from GAME_DATES.

To participate in the Game, the participant must:

1. Register to the online event called GRAITEC Innovate2Build until 29 february 2024 inclusive.
2. Be a certified professional (architect, engineer, detailer, designer, etc.) from the construction industry.
3. Fill out the registration form for the operation by completing the following mandatory fields indicated by an asterisk:

ARTICLE 5 – PRIZES AND PRIZE ALLOCATION

The following prizes will be awarded to the 3 winners by prize draw among participants of the corresponding operation on March 5, 2024, by GRAITEC INNOVATION team:

Prizes to be won: 3 iPad Air worth 998 euro each.

The conditions for sending the prizes are governed by the organization responsible for the security and transport of the prizes and do not engage the responsibility of the Organizing Company. In the event that the Participant does not claim their prize where their parcel has been placed for reception, they will be considered as having waived their prize. Prizes not finding the winners within 15 consecutive days will be returned to the Organizing Company. The Organizing Company reserves the right to replace the announced prize with an equivalent prize of the same value and similar characteristics if circumstances so require. The prize cannot be contested in any way. The winner cannot claim the cash equivalent of the prize won or request its exchange for other goods or services. In the event that the winner does not want or cannot, for any reason, benefit from all or part of the prize won, in the conditions described in this regulation, they lose the full benefit of said prize and cannot claim any compensation or counterpart. The prize will not be put back into play and the Organizing Company can dispose of it freely. Winners of the game authorize any verification regarding their identity. Any identity check refused will result in their elimination. Likewise, the Organizing Company reserves the right to pursue by any means any attempt to circumvent this regulation, particularly in the case of incorrect information.

ARTICLE 6 – DESIGNATION OF WINNERS AND ALLOCATION OF PRIZES

Winners will be announced on March 20, 2024, during Manuel Liedot's conference that start at 2PM UTC time. They will also be notified by email on March 21, 2024, via the email address provided by them at the time of their participation in the game, within a maximum period of 15 days. They must confirm the delivery address of the prize within 30 days. Failure to respond within 30 days after receipt of this message will result in the winner forfeiting the prize.

Only one prize may be awarded per person during the entire duration of the game (one prize per winner: same name, same address).

ARTICLE 7 – FORCE MAJEURE

The Organizing Company cannot be held responsible if, for reasons beyond its control and/or in the event of force majeure, the game were to be shortened, modified, postponed or canceled; and this without any compensation being due to the participants. The Organizing Company cannot be held responsible if, for reasons beyond its control, technical malfunctions, computer bugs, or any other technical problem were to impact the smooth running of the game or the list of winners. Complainants could then not claim any prizes whatsoever. The Organizing Company cannot be held responsible in the event of theft, misdelivery of mail, or damage to prizes by postal services/courier.

ARTICLE 8 – ADVERTISING

By participating, each winner authorizes the Organizing Company to use their names and first names in any public-promotional event related to this Game, without this use conferring on the winner a

right to remuneration or any other advantage other than the award of the prize won. In any case, the use of this personal data in this type of event related to the Game cannot exceed 12 months after the end of the Game. The Organizing Company cannot be held responsible in the event of Internet network malfunctions, particularly due to acts of external maliciousness, which would prevent the smooth running of the Game. Specifically, the Organizing Company cannot be held responsible for any damage caused to participants, their computer equipment, and the data stored on it, as well as the consequences that may arise on their personal or professional activities, except in the case of the Organizing Company's direct and exclusive fault. Furthermore, the liability of the Organizing Company cannot be retained in the event of problems with routing or loss of postal or electronic mail. The Organizing Company cannot be held responsible if one or more participants are unable to connect to the Game site or play due to any technical problem or defect, particularly due to network congestion or malicious acts.
